# Legislative Update

On January 8, Congressional leaders announced a top-line appropriations deal that was hoped to expedite completing appropriations for FY24 without another Continuing Resolution. However, with the January 18 third continuing resolution, the can was kicked down the road to March 1, for MilCon/VA, Energy/Water, Transportation/HUD, and Agriculture. All other bills, including Defense, expire on March 8

If the two deadlines pass without passage of the 12 funding bills, the compromise Continuing Resolution agreement from 16 Nov 2023, states the government would operate with a 1% spending cut across the board. This is vehemently opposed by Senate leaders, House Democratic leadership, and Republican House members from vulnerable districts.

We must continue to push our Senators and Representatives to work toward a compromise budget that will address the country's needs. I am asking you to act immediately using the <u>MOAA Legislative Action Center</u> and click on the topic:

*"Ask Your Lawmakers to Avoid a Government Shutdown and Finish the Appropriations Process."* I also urge you to call and leave a personal message urging our elected representatives to put aside election-year partisanship and concentrate on the business of the nation. Press them to support quick action on a compromise budget that puts the people, our national security, and our economy first!

Remind them that as members of MOAA, we are not just constituents, but we are voters as well! If they are unwilling to put the good of the nation first, then we will remember their inaction at the polls.

Arizona Legislative News: There is some important news out of Phoenix! Sen Dave Gowan, District 19 and Chair of the Military Affairs committee has reintroduced legislation to address active duty pay parity for USPHS and NOAA officers serving in Arizona. <u>SB1413</u>: Income Tax; Subtraction; Uniformed Services awaits a reading and assignment to committee. Three Senators and seven Representatives signed on as co-sponsors. There are no Senate or House co-sponsors from our four catchment districts. I urge you to immediately contact our Senators and Representatives and ask them to co-sponsor this important legislation. The passing of SB1413 will be the number one legislative priority for MOAA-AZ. Please take time to contact our legislators and ask them to support SB1413.

The Tucson and CMC member catchment areas are comprised of Legislative Districts 17,18, 20, and a part of 21.

# **February 2024 D-M RAO Meeting**

RAO Director Charles Schable's (CAPT, PHSCC, Ret) wife is out of the hospital but caught a bacterial infection there and is undergoing intensive antibiotic treatment at home. The foregoing, combined with low staffing and budget will probably lead to no RAO Volunteer Appreciation Day this year. The RAO needs a Thursday volunteer. The hours are 0900-1400 and there is training. The RAO refers people to appropriate on-base or veteran support organizations; it is not social work.

**Base News:** Col Amy Meier, Acting 355 Deputy Wing Commander reported that the Secretary of the Air Force Frank Kendall III will announce the major command changes shortly. D-M becoming home to the third power projection wing of the AF Special Operations Command (AFSOC), at least currently, will not change the Air Combat Command's ownership of the base. The next few years will see waves of people moving out and moving in. Also, there is going to be significant construction. The watchwords are hurry up and wait.

Entry and exit at the 24/7 Craycroft Gate will shut down by the end of next week and remain shut for several months for repairs and reconstruction. The only 24/7 gate will be Swan. **Special note:** visitors will need to go to the Visitor Check-in outside Craycroft and then return to Swan for entry.

There was some discussion about the continuing pinch of recruitment and retention and the positive impact of two recent military-affiliated individuals having broken into popular culture. Air Force Academy graduate and active-duty 2<sup>nd</sup> Lt Madison Marsh was recently crowned 2024 Miss America, a first for all the services. Also getting airplay is the 2024 Grammy nominations of duo <u>The War and Treaty</u>, US Army Iraq War veteran, Michael Trotter, Jr, and his wife, Tanya for Best New Artist and Best American Roots Song. Their live rendition of "Cold," the Chris Stapleton classic, during the show, available at the link above, is "trending" on social media. In December, <u>The War and Treaty</u> undertook a short USO tour of three South Korean bases and Guam. <u>Stars and Stripes</u> has an excellent interview with Michael about how his time in the Army and Iraq helped him to create his music.

**Exchange:** Manager Hafeeza McCullough reported that the HVAC switchout went smoothly and the renovation has gone smoothly. The Food Court renovation is complete and both Subway and Popeyes are fully operational; there is one empty slot in the Food Court. The renovation of the Shopette and Burger King will commence once the paperwork is complete. It is expected there will be 30-60 days of construction. Both will be done in stages so there will be no complete shutdown.

**Pharmacy:** Director Sally To reiterated that as of 1 February 2024, the Pharmacy phone line (520-228-2778) hours changed to 0730-1300. After 1300 all prescription activations will be done via Q Anywhere app messaging or in person. The Pharmacy upgrade for remote activation for new/ renewal prescriptions is active. Special formulary meds are at the Annex pharmacy which has more storage.

**Support Squadron:** Several base activities are scheduled for D-M's 16<sup>th</sup> celebration of Rodeo Week including a mechanical bull! The kitchen has modified hours. Retirees are encouraged to go to the Fitness Center and get their 24-hour access cards. There will be a Superbowl Party at the Bowling Center; big screens, open bar. The AF awarded D-M the Military Family Readiness Center of the Year.

There is a big voter registration push base-wide. The Readiness Center has a computer at the computer hub that allows for registration in one's home state. On May 8 there will be Federal Voting Act training for point persons in the Wing.

**On-base VSO:** John Roseberry, the accredited on-base VSO said he had been fielding several DTC issues for Surviving Spouses (SS). He wants to get the word out about the importance of free VSO representation when filing claims. VSO volunteers are trained and accredited by the VA and if given formal representation, can access VA claim records electronically.

He was able to get a resolution to a case that began in 2015. The widow had been rejected previously, but with the PACT Act broadening presumptive conditions, she filed again but heard nothing. Mid-January, the widow got in contact with John and he found she had no representation. He executed the paperwork for the American Legion to be her representative, which came through on 02 February 2024 allowing him to access her records in the VA system. He discovered something had been dropped, and he was able to contact the right person at the VA and get the claim fixed on the spot. VA Benefit Management System executed a retroactive check and that morning, he fielded a call that \$19,940 was in the widow's direct deposit, with more to come.

VITA: In the past week, logging 456 hours, VITA volunteers had had assisted taxpayers filing 256 state forms with \$106k refunds and 241 federal forms with \$380k refunds. In addition to appointments, two days a week are open to walk-ins. **Society of Military Widows:** The local chapter has been holding steady with 23 members. Over the holidays they were able to donate \$600 to Operation Warmheart, which is run by First Sergeants and gives financial support to D-M families in need. **RAO Newsletter:** Barb Estes, the editor, has a new goal of 750 subscribers, which she hopes to attain faster than the decade it took her to get 500 subscribers. The pdf newsletter is free. **TMC Hospice:** The Hospice currently has 16 beds and has in-home hospice care available from Benson to Saddlebrook.

# **MOAA's Spring Advocacy Push**

The three issue areas comprising this year's Advocacy in Action (AiA) campaign show the range of MOAA's legislative priorities – not just for officers, not just for retirees, and not wavering on our commitment to long-term advocacy goals. Here's a quick look at each of the issues, which were approved by MOAA's board of directors Jan. 19. Get involved! <u>Click here for details</u>.

**CONCURRENT RECEIPT What's at Stake:** The Major Richard Star Act (H.R. 1282/S. 344) would end an unjust offset for combat-injured veterans who lose a dollar of service-earned retirement pay for every dollar of VA disability compensation. The bill has a supermajority of bipartisan support – more than 325 House co-sponsors and more than 70 in the Senate – thanks in part to past grassroots efforts from MOAA and partners in <u>The Military Coalition</u>. **MOAA's Mission:** We need to keep up this momentum and secure the bill's inclusion in the FY 2025 National Defense Authorization Act (NDAA). It's time for lawmakers to push this long -delayed step toward concurrent receipt for all past the finish line. <u>Ask Your Legislators to Support Combat-Injured Veterans</u>

**FULL HOUSING ALLOWANCE What's at Stake:** The BAH Restoration Act (H.R. 2537/S. 1823) reverses DoD policy capping the Basic Allowance for Housing (BAH) at 95% of local rental and utilities costs – a policy that's placing a financial burden on servicemembers and families in the middle of a nationwide rental shortage *and* ongoing recruiting challenges. Restoring this benefit – it was cut by Congress incrementally beginning in 2015 – would make a difference in the quality of life for all who serve, but especially among junior enlisted members and their families, who rely on this allowance as a large percentage of their compensation. **MOAA's Mission:** Language requiring an incremental increase reached the late stages of the FY 2024 NDAA process but ultimately was not included in the final bill. We must send a message to lawmakers that close isn't good enough – servicemembers deserve a full housing allowance, and more progress must be made this legislative session. <u>Ask Your Legislators to Support Full BAH for Servicemembers</u>

**TRICARE FOR LIFE What's at Stake:** Protecting TRICARE For Life (TFL) remains a key issue for all MOAA members – those already covered by TFL and Medicare, along with those who'll use the benefit when they turn 65. MOAA remains concerned about a <u>Congressional Budget Office (CBO) report</u> suggesting two measures which would severely weaken the benefit – enrollment fees topping \$1,100 per family, and cost-sharing requirements including an \$850 deductible and up to \$4,675 in potential yearly medical bills. **MOAA's Mission:** Legislators seeking solutions to budget gaps must hear a clear message: Maintaining TFL is not just a national obligation to those who spent decades in uniform, it's also critical to ensuring key influencers in the recruiting process aren't discouraged from recommending uniformed service to future generations. While TFL fees or cost shares aren't part of any current legislation, we must counter CBO's misguided options with our grassroots advocacy efforts. The next CBO release is slated for December of this year, following the elections; MOAA will update our members as soon as we get the report.

**Take Action Online:** MOAA's last online advocacy effort addressing potential TFL fees resulted in nearly 49,000 messages to lawmakers. Register for <u>MOAA's Legislative Action</u> <u>Center</u> today so you can be part of upcoming campaigns.
