The February luncheon presentation by Dena Kilgore, MOAA Program Director, Council, and Chapter Affairs, was informative. She reiterated that MOAA is committed to its mission and to maintaining key advocacy and mission. She noted that MOAA was named to The Hill's Top Lobbyist for the 18<sup>th</sup> consecutive year.

From AZCOC Legislative Liaison, Tom Waddell: [February 14], I received a call from Senator Kelly's office responding to an email I recently sent concerning the **ACES Act**. This bipartisan legislation, the Aviator Cancers Examination Study (ACES) Act, seeks to address the disproportionately high cancer rates among aircrew members from the Army, Navy, Air Force, and Marine Corps. Senator Kelly introduced the act in the last congress but did not receive committee support. I asked Senator Kelly to please reintroduce the legislation in the 119th Congress, and the call this morning confirmed that his Veterans Affairs staff is working on the legislation, and it will be reintroduced. I will be asking MOAA to add the ACES Act to its priority legislation roster. Once it has been reintroduced, I will ask you to support the legislation even if it does not make the cut at MOAA.

The call from Senator Kelly's office this morning confirms that grassroots advocacy works!! Please urge your members to register and become active in the MOAA LAC.

commissioned USPH and NOAA officers who are state residents will be eligible to have their active-duty pay be exempt from state income tax as their retirement pay currently is, has passed the Senate. # Budget Update

House Speaker Mike Johnson abandoned his “big beautiful bill” on March 8, 2025. The bill passed the House on February 25 with a two-vote margin. The March 14 expiration of the current Continuing Resolution (CR) was looming and Senate leadership had declared that reconciliation would take at least until mid-April.

Unveiling a new strategy, he proposed a CR that would expire on September 30 and keep overall spending levels at FY2024, minus about \$13 billion in non-defense discretionary spending; about \$16 billion would be added to defense spending. The bill would also allow the Administration to move money around for its priorities, thereby punting Congressional fiscal responsibility on a fully funded FY2025 budget.

The House passed the revised Continuing Resolution (CR) 217-213 on Tuesday, March 10. It now goes for a vote in the Senate, which must meet a 60-vote threshold to pass the bill. In an act of brinkmanship, GOP House leadership announced early Tuesday that the House would adjourn and start a week-long district work period earlier than expected. If the Republican majority in the Senate cannot muster the extra votes to pass the CR, the House must call back House legislators to hash out a mutually acceptable spending bill or face a government shutdown of all but essential workers.

The brinkmanship comes amid economic jitters among many sectors, ranging from manufacturing, farmers, education and health care sectors, and blue- and white-collar workers. The President has teed off a global trade war with erratic tariffs, increasing inflation. The federal workforce is reeling from dangerous micromanagement and missteps by the White House Office of the DOGE, inexperienced leadership at the Cabinet level, and erratic plans and implementation of an across-the-board reduction in force.

The President has acknowledged that his monetary, fiscal, and economic policies may inflict pain but views it as a “transition.” Asked directly on March 11 whether he thought the country

was headed towards a recession, he responded, "I don't see it at all. I think this country is going to boom. But as I said, I can do it the easy way or the hard way. The hard way to do it is exactly what I'm doing. But the results are going to be 20 times greater."

After the FY2025 budget standoff is resolved, both Houses have two looming fiscal issues. Since the 2017 Tax Cut and Jobs Act, the government has added an average of \$2 trillion yearly in new debt as income, primarily from income taxes, outpaces revenue. The Senate and House Republicans have not abandoned the extension and expansion of the 2017 tax cut, which will expire in December 2025. But it will have to be a stand-alone bill. The proposed tax cut is closely tied to the debt limit as it is forecast to add a minimum of \$5 trillion to the debt coming primarily from cutting the top 1% and corporate tax rates from those set in 2017.

The Johnson CR keeps FY2024 levels for the rest of FY2025, which might give the Treasury Department some breathing room to employ extraordinary measures before Congress must meet its Constitutional responsibility to raise the debt limit ceiling, currently \$36.1 trillion, or risk default. Since January 17, the Treasury Department has taken extraordinary measures to keep the debt from defaulting. The Treasury Department maintains a [debt limit webpage](#) that tracks daily debt subject to extraordinary measures and a short paper, "Description of Extraordinary Measures," dated January 17, 2025.

Presenters included the OSD Acting Deputy Assistant for Military Community and Military OneSource, a representative from Casualty and Mortuary Affairs, two senior officials from the DFAS Retired Military and Annuitants office, a senior official from the Office of Survivors Assistance at the VA, and two financial counselors for the US Army that provide advice surviving spouses and surviving children. The three-hour meeting was comprehensive, and I will cover each segment in future newsletters.


There is a full-on indefinite hiring freeze in effect. With the thrash, assuring civilian employees that they have not lost their jobs. This arose because civilian employees have been included in

the five-bullet point email blast, which originated initially from OPM. After consideration and asking civilian employees to pause responding on February 28, SecDef Hegseth reversed course, though the memos are to be submitted to OSD, which will compile them for OPM. Here is a DoD link to [SecDef Hegseth's video](#) explaining the directive March 2. (As a side note, the RAO office staff with .mil addresses were also included in the email blast, even though they are volunteers.)

The 355<sup>th</sup> Mission Support Group is working with civilian employees to develop a description of how each job on the base contributes to lethality: base support and installation, southern border support, etc. Everyone is here for a purpose. At this point, there is no drop in on-base services, and retirees can—and are encouraged—to access services. While OSD targets for RIF are being considered, they are not yet in place, and it is unclear how they will affect the base.

The pharmacy is still open and has its budget. It will have regular hours during the Air Show. Keep in mind the Pharmacy is closed on Sundays.

## Francis Gary Powers Jr.



The son of Francis Gary Powers, famed U2 Pilot, Air Force Veteran, and CIA employee will be participating in the Annual Tucson Book Festival in March. The SaddleBrooke Ranch Veterans Club has the opportunity to have him as a guest speaker here at SaddleBrooke Ranch.

Powers is best known for his involvement in the 1960 U-2 incident, when he was shot down while flying a secret CIA spying mission over the Soviet Union.

Francis Gary Powers Jr. is the Founder and Chairman Emeritus of The Cold War Museum. Gary founded the museum in 1996 to honor Cold War veterans, preserve Cold War history, and educate future generations about this time period. He worked with the National Park Service and leading Cold War experts to identify historic Cold War sites for commemorating, interpreting, and preservation. In 2015, he consulted for a Steven Spielberg Cold War thriller, *Bridge of Spies*.
